PRIVACY STATEMENT

Purpose of Personal Data Processing

Novuqare Pelvic Health B.V. and/or Novuqare Hospital Equipment B.V. process personal, privacy-related data for one or more of the following purposes:

- Supplying products, for example the sale of a Maple system and associated products; or
- Supplying information to recipients, for example when you subscribe to a newsletter.

Legal Basis for Processing Personal Data

Novuqare Pelvic Health B.V. and/or Novuqare Hospital Equipment B.V. process your personal data on one or more of the following legal bases:

- When buying a product, for example the Maple system, processing of personal data is required to execute the purchase contract,
- When filling in a contact form or when you request information, personal data will be processed on the basis of consent given by the recipient. You have the legal right to withdraw consent for the use of your personal data at any time.

Sharing of Personal Data

Novuqare Pelvic Health B.V. and/or Novuqare Hospital Equipment B.V. will not supply any personal data to third parties, except with business partners directly involved in the sales and possible service of products.

Retention of Personal Data

When you purchase a product, Novuqare Pelvic Health B.V. and/or Novuqare Hospital Equipment B.V. will retain personal data for at least the life time of the product.

When you request information, Novuqare Pelvic Health B.V. and/or Novuqare Hospital Equipment B.V. will retain personal data for as long as the information is supplied. For example, when you subscribe to a newsletter, your personal data will be retained for as long as you receive the newsletter, unless and until you cancel your subscription to the newsletter. Legal rights

You have the right to request to review, alter and/or delete the personal data being processed. In addition, you have the right to request to limit the processing of your personal data and object to the processing of your personal data.

You also have the right to request to receive a copy of your personal data that Novuqare Pelvic Health B.V. and/or Novuqare Hospital Equipment B.V. have on file. This data must be offered to you in a structured, common and accessible format that can be processed with the aid of a machine, e.g. a computer, to enable you to port your personal data to third parties at your discretion.
